### Data protection declaration of consent for the Deutschen Club für Kooikerhondje e.V. to the processing of personal data, Art. 7 DSGVO

I agree that the Deutscher Club für Kooikerhondje e.V. based in Aschaffenburg, VR 1326 and its elected and appointed officials as well as all persons commissioned by the board of directors may store and process the data collected about me, such as personal data and address, photos from or with my person or taken by me as well as reports and writings made available by me.

This includes, for example, saving personal data and address in an Excel member list that is only accessible to officials and persons commissioned by the board, the publication of pictures with or from me, writings and reports, exhibition and health results of my Kooikerhondje(s) on the club website and in the members' area of the DCK e.V. homepage, saving test results such as HD and PL on the vetsXL.com platform and sending them to the DCK e.V. stud book office, storing personal data in the stud book office and in the club's own breeding software "Breedersoft" in connection with my dog(s), or similar.

For this it is necessary that an Excel list of members with my personal data and address is stored locally on different computers by different officials. In addition, a monthly updated version is accessed by the same officials via a "shared solution". Furthermore, images, writings and reports are stored on the servers of our hosting provider for processing on the homepage and the members' area of DCK e.V. To create the club's own club magazine "Kooikerwelt", pictures, writings, reports, exhibition and examination results, kennel names and the associated personal data and addresses are recorded by the officials of the editorial team, processed and sent to a print provider such as "We make pressure. en" provided. Further processing of data is only carried out with the consent of the person concerned.

If it is possible that conclusions about my ethnic origin, religion (e.g. wearing certain items of clothing, or mentioning the country of birth, etc.) or health (e.g. wearing wearing glasses, or mentioning the wearing of glasses in a report) could be concluded, my consent expressly also refers to these circumstances.

I am aware that my photos, writings and reports are accessible worldwide on the Internet. These photos, writings and reports could easily be copied and processed by third parties without my necessarily being aware of this.

This consent is voluntary. I can refuse them without giving reasons and without fear of any disadvantages. I can also revoke this consent at any time with effect for the future.

I can declare my revocation in writing by post, by e-mail, or by telephone to the first chairman of the Deutscher Club für Kooikerhondje. The following contact details can be used for this:
